FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR WALNUT RIDGE, A PLANNED COMMUNITY.

THIS AMENDMENT to the DECLARATION OF COVENANTS, CONDITIONS AND

RESTRICTIONS FOR WALNUT RIDGE, A PLANNED COMMUNITY (hereinafter the "Declaration") is to be

effective upon the date of its recording by THE WALNUT RIDGE HOMEOWNERS' ASSOCIATION

(hereinafter the "Association").

WITNESSETH

WHEREAS, pursuant to the Declaration of Walnut Ridge, A Planned Community recorded in the

Recorder of Deeds Office in and for Butler County, Pennsylvania, at Instrument No. 201810260021816 pursuant

to the Pennsylvania Uniform Planned Community Act, 68 Pa.C.S. §§ 5101, et seq. (the "Act"), the Association is

a homeowner's association located in Jackson Township, County of Butler, Commonwealth of Pennsylvania; and

WHERAS, pursuant to Article V Section 5.4 of the Declaration, the Association reserves the right to

amend the Declaration by affirmative vote of two-thirds (67%) of all Owners entitled to vote; and

WHEREAS, the approval required in the Declaration has been obtained; and

**NOW THEREFORE**, intending to be legally bound hereby, the Declaration of the Association is hereby

amended as follows:

1. Section Article VIII Section 8.1(f) - Garbage and Refuse Disposal

REMOVE: "(f)...Garbage containers must be kept out of public view except on

collection days."

ADD: "(f)...Garbage containers may not be stored in the front of the home except on

collection days. Outside of collection days, the containers are to be stored either in the

garage or on the side of the home."

2. Section Article VIII Section 8.1(i) - Temporary Structures

REMOVE: "(i)..shed,".

3. Section Article VIII Section 8.1(n) – Storage and Parking of Vehicles

ADD: "(n)...Overnight street parking is only allowed in limited circumstances for

limited periods of time if given consent by the Board of Directors of the Association."

Except as specifically amended hereby, the Declaration, remains in full force and effect in accordance

with its terms.
