AMENDMENT TO THE BYLAWS OF SADDLEWOOD CONDOMINIUM ASSOCIATION

WHEREAS, the Saddlewood Condominium Association is located in South Fayette Township, Allegheny County, Commonwealth of Pennsylvania.

WHEREAS, the Saddlewood Condominium Association was created by the filing of a Declaration at the Allegheny County Department of Real Estate (formerly known as the Allegheny County Recorder of Deeds Office) at Deed Book Volume 9939, Page 586; and

WHEREAS, pursuant to the terms of the Uniform Condominium Act of Pennsylvania and the Declaration and Bylaws of the Saddlewood Condominium Association the affairs of the Association are managed by an Executive Board; and

WHEREAS, Article 7, Section 7.1 of the Bylaws provides for the amendment of the Declaration at Saddlewood Condominium Association; and

WHEREAS, pursuant to Article 7, Section 7.1 of the Bylaws, the Bylaws may be modified or amended only by vote of Unit Owners entitled to cast a majority of the votes in the Association, except as otherwise expressly set forth therein or in the Act;; and

NOW, THEREFORE, the Bylaws of Saddlewood Condominium Association are hereby amended as follows:

Section 1: Article 5, Section 5.7 of the Bylaws is hereby deleted in its entirety and replaced with the following:

5.7. Accounting: Audits. All sums collected by the Executive Board with respect to assessments against the Unit Owners or from any other source may be commingled into a single fund. All books and records for the Saddlewood Condominium Association shall be kept in accordance with good and accepted accounting practices. There shall be an external review/audit, as determined by the Board, every three (3) or four (4) years. There may also be an external review/audit whenever an individual assumes

Section 2: To the extent of any inconsistency by and between the terms of this Amendment and the Bylaws and/or the Rules and Regulations of Saddlewood Condominium Association, the provisions of this Amendment shall prevail. All remaining provisions of the Declaration, Bylaws and Rules and Regulations of Saddlewood Condominium Association shall remain in full force and effective.
