Jerry Tyskiewicz, Director Rich Fitzgerald, County Executive AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR PHASE I OF THE HEIGHTS OF NORTH PARK PLAN OF LOTS

WHEREAS, Phase I of the Heights of North Park is located in Pine Township, Allegheny County, Pennsylvania; and

WHEREAS, Phase I of the Heights of North Park was declared pursuant to the provisions of the Unit Property Act of Pennsylvania, Act of July 3, 1963, P.L. No. 196, 68 P.S. § 700 et. seq., by recording a Declaration, dated April 20, 1990, with the Recorder of Deeds for Allegheny County, at Deed Book Volume 8230, Page 146; and

WHEREAS, the Condominium Council of Phase I of the Heights of North Park believes that it is in the best interest of the Association to remove the prohibition against detached garages as doing so will maintain consistency within the community; and

WHEREAS, the Declaration at paragraph 27 expressly provides it may be amended by a writing executed in recordable form by the Owners of eighty percent (80%) of the Lots or their respective heirs, successors and assigns. The Amendment set forth herein was approved pursuant to the terms of paragraph 27 of the Declaration for Phase I of the Heights of North Park as more than 80% of the Unit Owners approved it as 101 of the Owners returned ballots in favor of the Amendment.

NOW, THEREFORE, The Declaration for Phase I of the Heights of North Park is hereby amended as follows:

Section 1: The following language shall be deleted from paragraph 3 of the Declaration for Phase I of the Heights of North Park:

08-701-3030 13:33b/IMF 88: 88

"All dwelling structures on the Lots shall have attached or integral garages of such width to park at least two standard sized automobiles side by side, no detached garages shall be permitted."

Section 2: The following language shall be added to paragraph 3 of the Declaration for Phase I of the Heights of North Park:

"All dwelling structures on the Lots shall have attached or integral garages of such width to park at least two (2) standard sized automobiles side by side."

Section 3: Except to the extent inconsistent herewith, all remaining provisions of the governing documents for Phase I of the Heights of North Park, as amended from time to time, shall remain in full force and effect as this Amendment is intended to be limited in scope.

Section 4: This Amendment shall become effective upon the date of recording with the Allegheny County Department of Real Estate (formerly known as the Allegheny County Recorder of Deeds Office).
